We are again requesting reimbursement for legal services rendered to Dr. Manos Antonakakis from January 1, 2022, through February 28, 2022. Please see attached bills and payments made by Dr. Antonakakis.

Summary: This situation initially involved a government investigation out of Washington, DC that sought information from Dr. Antonakakis directly, in his individual capacity, but related to his work here at Georgia Tech. We sought assistance from the Attorney General's office who declined to assist Dr. Antonakakis; however, permitted us to reimburse Dr. Antonakakis for legal costs he incurred for hiring his own counsel. In October of 2021, a foreign corporation, who had filed an unrelated civil lawsuit, sought the same information as the government investigation from Dr. Antonakakis individually, but related to his work here at Georgia Tech. Again, we sought assistance from the Attorney General's office and again they declined to assist Dr. Antonakakis but maintained the same position on reimbursement for outside counsel.

04/20/2022 UPDATE: The civil lawsuit filed by the foreign corporation has been withdrawn. However, the government investigation has continued and has led to in an indictment against a third party. The matter is set for a jury trial next month. The government has asked Dr. Antonakakis to remain involved, which continues his need for counsel. Hopefully after the trial, the matter will end.

By reference, there was a prior request reimbursement on this same matter (EXP-1076481). Please let me know if you have further questions.

04/20/2022 UPDATE: The civil lawsuit filed by the foreign corporation has been withdrawn. However, the government investigation has continued and has led to in an indictment against a third party. The matter is set for a jury trial next month. The government has asked Dr. Antonakakis to remain involved, which continues his need for counsel. Hopefully after the trial, the matter will end.

6/15/2022 UPDATE: The criminal trial has concluded resulting in an acquittal of the defendant charged. Dr. Antonakakis

did not have to testify as a witness. We expect that because the trial has concluded, continued representation for Dr. Antonakakis on this matter should conclude soon. I spoke with his counsel yesterday and confirmed that there should be one final invoice for services rendered through the end of May/beginning of June.

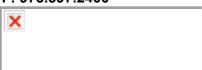
